## WHAT DOES PRIZEPOOL, INC.

### DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Account Balances
- Transaction History and Account Transactions
- Assets and Checking Account Information

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share customer personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons PrizePool, Inc. chooses to share; and whether you can limit this sharing.

What we do	
<b>How does PrizePool, Inc. protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured lines and buildings.
<b>How does PrizePool, Inc. collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ Open an account or deposit money</li> <li>▪ Provide account information or give us your contact information</li> <li>▪ Make deposits to or withdrawals from your account</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ PrizePool, Inc. has no affiliates</li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ PrizePool, Inc. does not share with nonaffiliates so they can market to you</li> </ul>
<b>Joint Marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ PrizePool, Inc. does not jointly market</li> </ul>
Other important information	
<p><b>California Residents:</b> Accounts with a California address are treated as if they have limited sharing as provided in this notice. California law provides that a consumer may opt out of certain marketing, which you may do by returning the enclosed Important Privacy Choices for Consumers document. PrizePool, Inc. will not share information we collect about you with nonaffiliated third parties, except as required or permitted by law, such as to process your transactions or to maintain your account.</p> <p><b>Vermont Residents:</b> We will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.</p>	

## IMPORTANT PRIVACY CHOICES FOR CONSUMERS

**You have the right to control whether PrizePool, Inc. shares some of your personal information. Please read the following information carefully before you make your choice below. This notice only applies to California Residents.**

### Your Rights

You have the following rights to restrict the sharing of personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts. This includes sending you information about some other products or services.

### Your Choices

**Restrict Information Sharing With Companies We Own or Control (Affiliates):** Unless you say “No,” we may share personal and financial information about you with our affiliated companies.

(\_\_\_\_) NO, please do not share personal and financial information with your affiliated companies.

**Restrict Information Sharing With Other Companies We Do Business With To Provide Financial Products And Services:** Unless you say “No,” we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you. Even if you say “No,” we may share as needed to provide services you request.

(\_\_\_\_) NO, please do not share personal and financial information with outside companies you contract with to provide financial products and services.

You may make your privacy choice at any time. Your choice marked here will remain unless you state otherwise. However, if we do not hear from you, we may share some of your information with affiliated companies and other companies with whom we have contracts to provide products and services.
